V. Zimmerle presented the Revised Fiscal Year 2022-2023 Year-End Revenue and Expenditure Report. First 5 Yolo had one outstanding receivable related to the Quarter 4 IMPACT 2020 reimbursement from First 5 California. Because it was received after September 30, 2023, the funds must be recognized as revenues for Fiscal Year 2023-2024 and as a deferred inflow of resources in Fiscal Year 2022-2023. There is a net zero impact on the Commission's projected closing fund balance on June 20, 2024, and no other year-end adjustments were required.

Item #10: Public Hearing: Fiscal Year 2022-2023 First 5 Yolo Annual Report to the Legislature and First 5 CA

First 5 Yolo reports annually to First 5 California and the State Legislature on First 5 Yolo's activities. The Annual Report includes three sections, AR1 which focuses on financial information, AR2 which focuses on demographic information, and AR3 which is a narrative section for Counties to share highlights.

For Fiscal Year 2022-2023, the Commission modified how it reports siblings of target children in the home to more accurately capture the full breadth of those served in its programs and balance administrative burden for program staff. In prior fiscal years, First 5 Yolo collected detailed demographic information on all children ages 0-5 in the home however, to reduce burden, this year detailed demographics were collected on the "target child" only. For sibling children ages 0-5, F5Y collected counts only. Additionally, for FY2022-23 reporting, F5Y elected to report children in the home ages 6-18. The State does not maintain a separate reporting category for children in the home ages 6-18 and allows County Commissions to choose whether to include or exclude these children when reporting numbers served. When County Commissions choose to include these children in the Annual Report to First 5 CA, they are included in the Primary Caregiver Category per the State's guidance. This year, different from previous years, F5Y is reporting siblings ages 6-18. In local evaluation reporting, F5Y splits the adult primary caregivers from the children 6-18 into Primary Caregivers and Other Family Members for more accurate public reporting.

As a result, F5Y is reporting a greater number of "unknowns" in its demographic detail as is expected with these changes. While the number of "unknowns" within each demographic category has increased, the agency is now better able to present the full breadth of those served in its programs.

The narrative portion of the Annual Report highlights the cross-sector collaboration between First 5 and county agencies. First 5 Yolo has also increased its commitment to using outside evaluators in analyzing and presenting outcomes for First 5 programs.

V. Zimmerle presented highlights from the Fiscal Year 2022-2023 Independent Financial Audit. For the fiscal year ending June 30, 2023 there were no findings from the Commission's Financial, Federal Single, and Compliance Audits. The Commission continues to remain in good health and realized a modest decrease in Net Position. This is largely due to the planned draw on Fund Balance to support multi-year initiatives aligned to both the Strategic Plan and the Long Term Financial Plan as well as an increase in Pension Liability. With the conclusion of this Audit period, First 5 Yolo will close its 7-year engagement with its current audit firm, JensenSmith Certified Public Accountants per best practice. Staff are preparing to release an Request for Proposals/Applications in early 2024 to solicit a new Auditor. V. Zimmerle has been in conversation with other First 5's to identify potential bidders with a history of working with other First 5 Commissions and expects the Commission will receive multiple bids.

Background

Background

Understanding that the COVID-19 pandemic has taken a devastating toll on families in countless ways, including lapses in healthcare, declines in mental health, financial strain, parental stress, and social isolation, First 5 Yolo proposed “Welcome Baby,” an ARP project directed at every Medi-Cal or uninsured baby born (across 3 years) to residents of Yolo County. Welcome Baby offers 1 home visit by a nurse more immediately postpartum (generally within the first two weeks of hospital discharge after birth) and 1-2 visits by a community healthcare worker within the following weeks for those assessed as requiring further assistance.

At their meeting on September 28, 2021, the Yolo County Board of Supervisors (BOS) unanimously approved First 5 Yolo’s “Welcome Baby” ARP Proposal as a “priority project,” identifying it as a program ready to meet immediate needs and fast-tracking the required contract and agreements to begin the effort. In November 2021, the County executed a contract with First 5 Yolo to begin the planning, launch, and execution of Welcome Baby. All three larger, local cities—Davis, West Sacramento, and Woodland—followed suit with match funding.

First 5 Yolo and direct service partners CommuniCare Health Centers (now CommuniCare+OLE) and Yolo County Children’s Alliance launched Welcome Baby services at the beginning of March 2022. Welcome Baby attaches to First 5 Yolo’s existing, successful CHILD Project: Road to Resilience infrastructure.

Executive Director Overview

Welcome Baby has shown inspiring results for families served and has identified those who might otherwise have been invisible to the system of care. Having been phased in according to planned design, hospitals and medical systems serving Yolo County families have now been networked to Welcome Baby, providing leading-edge improvement in maternal-child health coordination across 9 different medical systems.

In partnership with First 5 Yolo, The UC Davis Heal Equity Across the Lifespan (HEAL) Lab is providing in-kind evaluation and data support services for Welcome Baby. Led by Dr. Leigh Ann Simmons, the HEAL Lab has finalized the Year 1 Report, and Dr. Simmons will share insights and data from the Report in the presentation at the meeting.

Additionally, First 5 Yolo’s Integration and Implementation Officer, Dr. Sarah Hartman, will briefly update the status of Welcome Baby, now having served nearly 800 families.

First 5 Yolo thanks and commends its implementation partners, CommuniCare+OLE Federally Qualified Health Care Center and Yolo County Children's Alliance, for providing their invaluable, compassionate care for Welcome Baby patients. First 5 Yolo also values Welcome Baby's medical systems partners, Sutter Davis Hospital, Dignity Woodland Hospital, Elica Health Centers, Northern Valley Indian Health, Capital OB/GYN, Kaiser Permanente, Winters Health Care, and UC Davis Health, and thanks them for enthusiastically joining the effort to transform the system of care for maternal and child health.

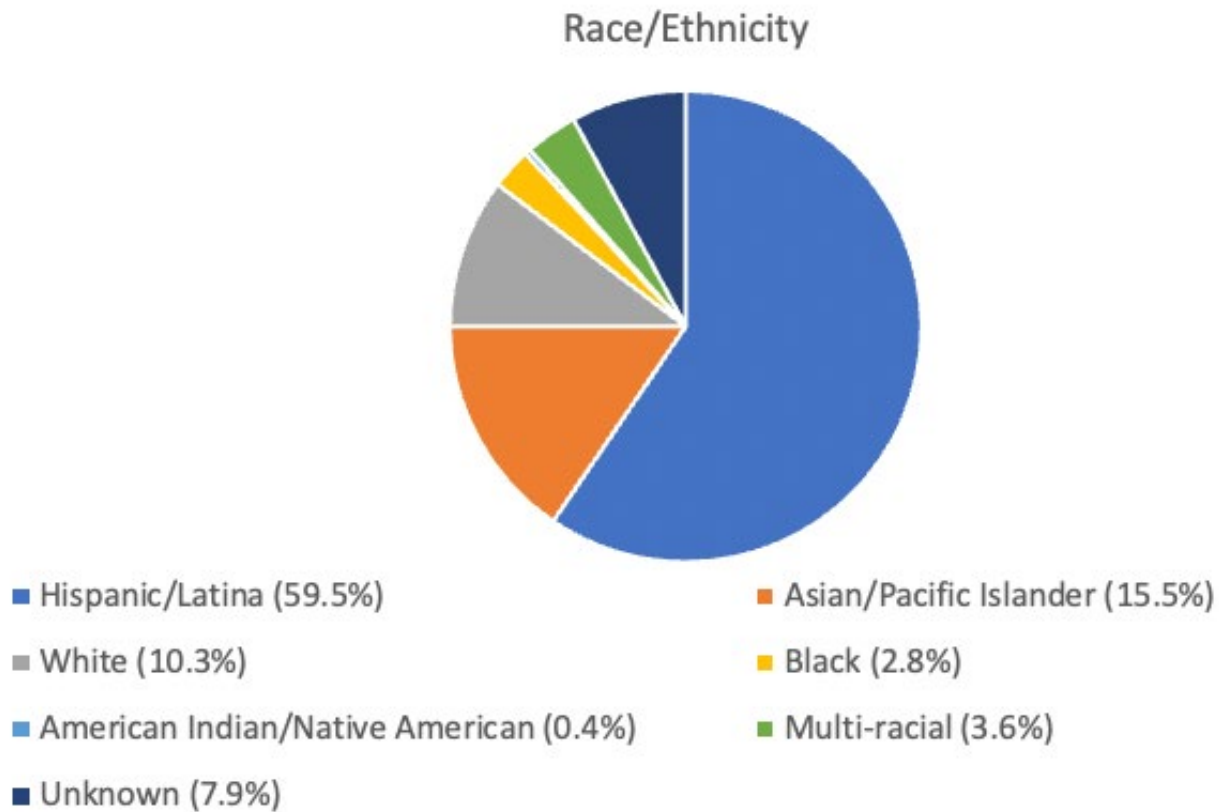

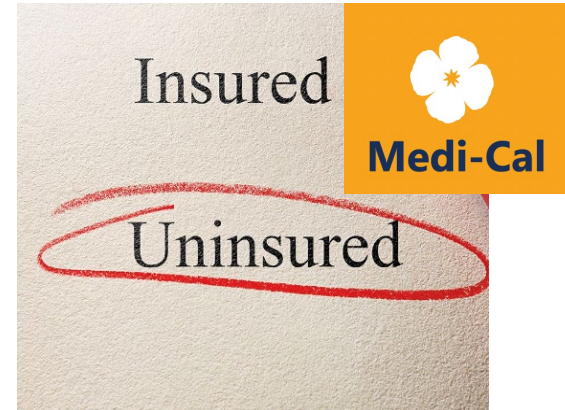
Welcome Baby Served a Diverse Clientele

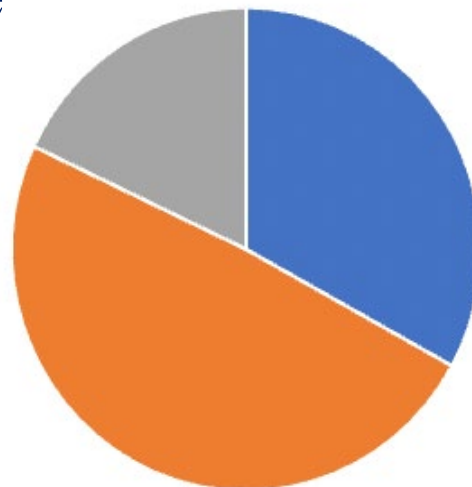

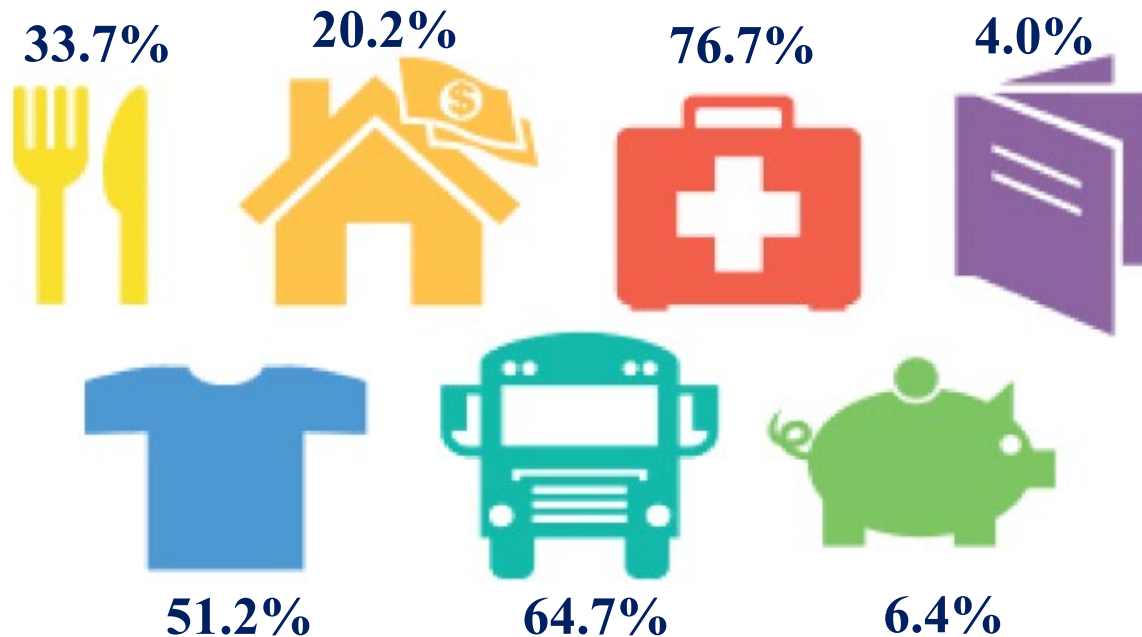

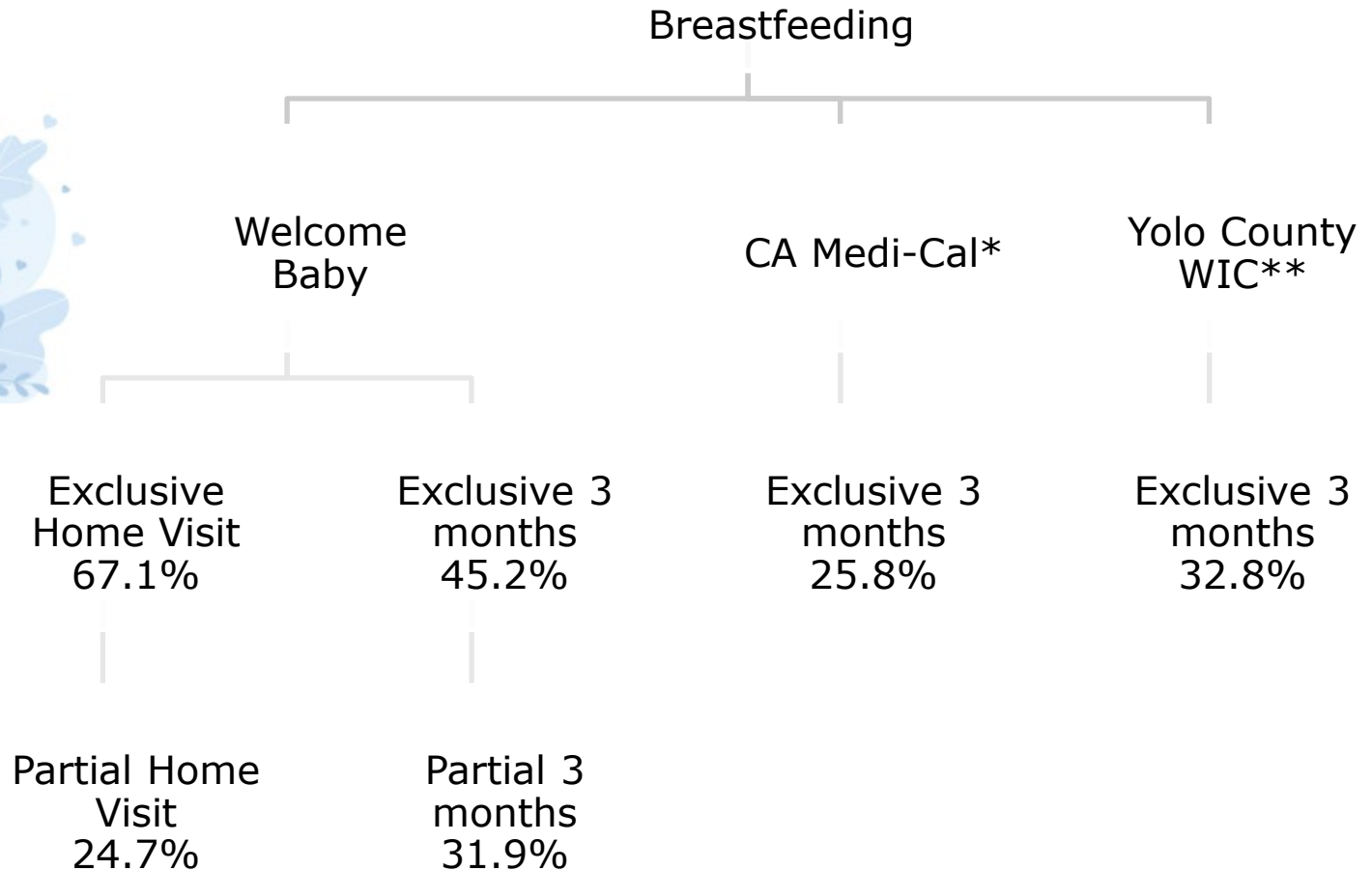

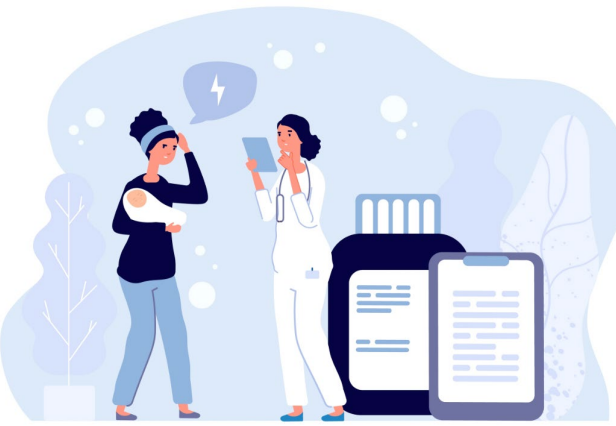

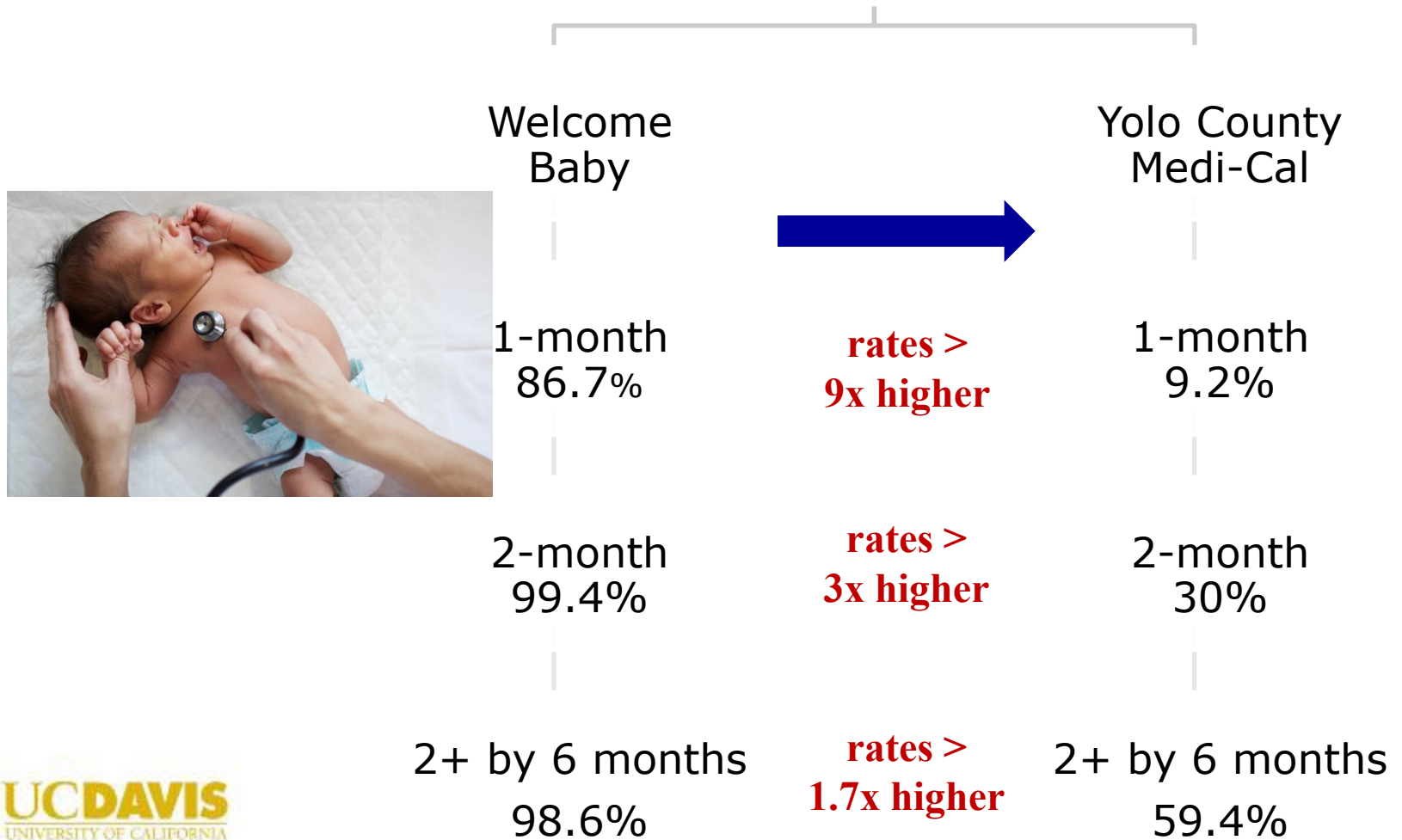

FY22/23**

Background

Per Statute, First 5 holds public hearings prior to adopting annual audits and reports. The First 5 Yolo Local Evaluation Report is an annual report summarizing the evaluation of funded programs and services and highlighting expected future work.

First 5 Yolo contracts with LPC Consulting, Inc. to provide local evaluation assistance. This is the fourth year of LPC's service to First 5 Yolo, after selection in a competitive RFQ process. LPC works with First 5 Yolo staff and funded partners to provide outside review of program level evaluation data, and First 5 Yolo staff works with funded partners on performance measures and analysis. First 5 Yolo staff summarizes overall agency results and shared measures across individual programs, as well as features some program highlights for each fiscal year. The Commission receives a Local Evaluation Report and a summary public presentation on the impact of First 5 Yolo investments near the beginning of each calendar year.

Executive Director Overview

The Local Evaluation Report highlights FY22/23 evaluation outcomes for First 5 Yolo's funded programs. This data is gathered from regular reports from partner agencies, as well as from additional local evaluation efforts. The Report reflects the progress and success of investments in First 5 Yolo Priority Areas as identified in the Strategic Plan and addressed by First 5 Yolo programs.

The FY22/23 Local Evaluation Report contains information from programs funded under the First 5 Yolo Children and Families Commission Strategic Plan Fiscal Year 2023/2024-2027/2028. Investments reflect First 5 Yolo's focus on better coordinating systems investments across its three major initiatives—The CHILD Project: Road to Resilience (R2R)/ Welcome Baby, Help Me Grow (HMG), and IMPACT. Each effort includes multiple contracts and may include multiple programs/services.

F5Y staff partnered with LPC to co-create a plain language infographic that helps make data more accessible and inclusive, and better communicates the mission and vision of F5Y in tangible terms. The approach also creates efficiencies with standardizing the local evaluation process.

This year, in the "Systems Change Makers" section of The Report, features a powerful statement from a Welcome Baby and R2R participant on how home visiting services helped to reduce their sources of stress and empower them on their parenting journey. F5Y highlights data to show how investments continue to lift family voices and drive equitable systems change for children 0 to 5 and their families.

First 5 Yolo collects and analyzes much more data than is contained in the summary Local Evaluation Report, and some evidence-based or national program models are also required to collect data beyond both the Evaluation Report and First 5 requirements. First 5 Yolo staff regularly review more data than contained in presentation documents.

The Local Evaluation Report is a *summary document* meant to clearly communicate key evaluation findings for First 5 Yolo investments and work. A final draft copy is presented as **Attachment A** to this item for Commission adoption during the following Agenda Item 10.

Notes:

- As F5 Yolo has intentionally moved to serving younger, prenatal-3 populations, as well as serving higher need/risk populations, the overall numbers served are lower, though services are often more targeted and/or intensive. Prenatal families are only counted under parents/unique families served, with the child contributing to counts at birth.
- F5 Yolo staff and evaluation teams have focused on making performance management improvements in recent years to capture more reliable and consistent data. This can affect numbers in a given program but yields more accurate information.
- F5 Yolo staff have worked with outside evaluator LPC Consulting Associates to develop a more responsive demographic reporting template. This will help partners report their data and identify trends in demographics. Not only will this help with more equitable outreach strategies, but it will allow validations to catch common errors noted in past reporting to improve data quality and enable timely course corrections.

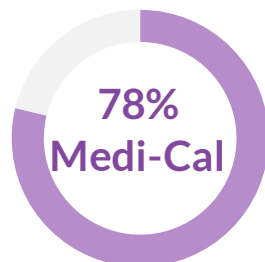
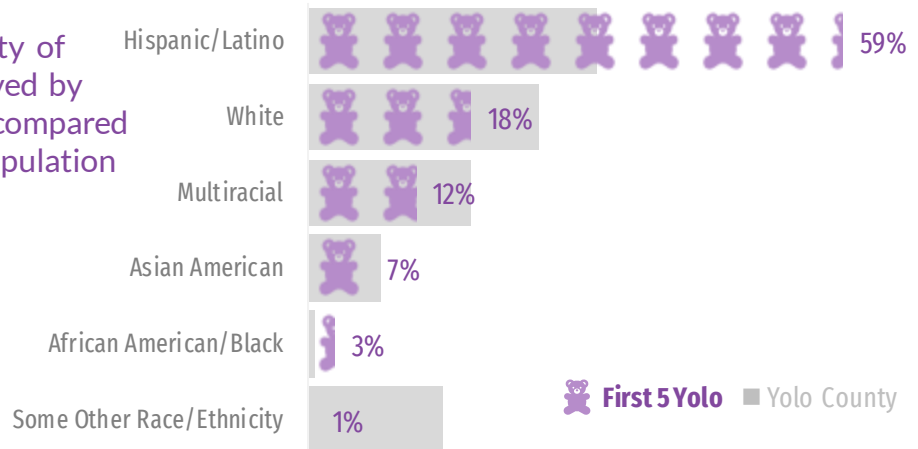

Background

Quarterly, the Commission reviews a Revenue and Expenditure Year-to-Date Summary Report tracking actual and projected revenues and expenditures against the current approved budget, and First 5 Yolo staff recommends changes to the budget based on the projections, if necessary.

Executive Director Overview

The Q1 Revenue and Expenditure Summary Report includes all funds received and expended from July 1, 2023-September 30, 2023, as well as expenses incurred and revenues earned in the defined period which were received within the period of availability, though funds may have been received or expended after September 30.

Of note are the following items:

1. Funds related to F5CA Prop 10 Grants are projected to be approximately 26% higher than budgeted as the Commission received its final IMPACT 2020 payment from the state after the close of the FY2022-23 period of availability, September 30, 2023. Because funds were received after the close of the period of availability, the final IMPACT 2020 reimbursement is recognized in FY2023-24.
2. Proposed budget revisions contained throughout The Revenue and Expenditure Report reflect correction to the Children's Home Society's allocation under the Childcare Recovery Package to correct for an error which understated the remaining balance of awards to childcare providers to be paid in Fiscal Year 2023-24, and to correct for an increase to both budgeted revenues and program expenditures related to the PRACTICE Initiative Grant from CommuniCare+OLE which allowed the extension of the project for an additional two months with additional funding to support initiative activities.
3. As of the close of Quarter 1, the Commission is projected to realize a contribution to Fund Balance of ~\$172K at the close of the Fiscal Year. Aligned with First 5 Yolo's Strategic Plan, these funds have been allocated to the Commission's Sustained Initiative Funding Reserve to support its largest multi-year initiatives in future periods as the Commission seeks to identify and secure additional funding to sustain its largest initiatives through the life of the current Plan.

Q1 Fiscal Year 2023-2024 Revenue and Expenditure Summary Report Notes:

1. Funds related to First 5 CA Prop 10 Grants are projected to be approximately 26% higher than budgeted as the Commission received its final IMPACT 2020 payment from the State after September 30, 2023. Because this final IMPACT 2020 reimbursement was received outside of the period of availability for Fiscal Year 2022-2023, this final reimbursement will be recognized in the current fiscal year.
 2. The Commission contracts with Children's Home Society for the disbursements of Childcare Recovery Package funding to childcare providers awarded grants under the program. CHS's contract was increased slightly to correct for an error which understated the remaining balance of awards to childcare providers to be paid in Fiscal Year 2023-2024. All Childcare Recovery Package expenses are reimbursable.
 3. In November 2023, CommuniCare+OLE, the fiscal agent for the PRACTICE Grant (second round of ACES Aware Network of Care Funding), received authorization from the funder to extend the term of their agreement through January 31, 2024, and the option for extension was offered to all lower-tier subcontractors. First 5 Yolo elected to extend the Agreement and additional funds were allocated to First 5 Yolo to continue work in the grant. Program expenditures as well as revenues are updated to reflect this extension.
 4. As of 9/30/2023, the Commission is projected to realize a contribution to Fund Balance of \$172,087 at June 30, 2024. As the fiscal year continues to unfold, the Commission expects year-end projections to improve as additional information and actual expenditures becomes available.
 5. The Beginning Fund Balance at July 1, 2023 was updated to match the audited ending fund balance at June 30, 2023.
 6. As of the close of the first quarter of Fiscal Year 2023-2024, the Commission's projected ending Fund Balance at June 30, 2024 is \$2,450,608.
- 7-11. The Commission's Fund Balance is allocated into four established reserves, each serving a different purpose. The Catastrophic Reserve is allocated to cover F5Y expenses for a short period should Prop 10 funding become significantly delayed or end, and/or a catastrophic event occur that disrupts business operations of F5Y. The Cashflow Reserve intended to smooth operations by ensuring adequate cash flow and stabilize program funding through each strategic plan despite month-to-month and year-to-year Prop 10 revenue fluctuation and/or delays in other funding sources, particularly those from state grants. The target balance for this account is \$500,000. The Cashflow Reserve also protects First 5 Yolo's funded partners who may not be able to withstand delayed reimbursements. The Sustained Initiative Funding Reserve supports the Commission's intended and committed leveraging activities in F5Y's largest multi-year grant-funded programs (e.g., The CHILD Project: Road to Resilience, and Welcome Baby). Through Fiscal Year 2023-2024, any excess funds over expenditures will be allocated to the Sustained Initiative Funding as the Commission seeks to capture and identify additional funding to support its largest multi-year initiatives through the life of the current Strategic Plan. Restricted Fund Balance is a non-formal reserve that reflects funds that are contractually restricted. Funds held in the Restricted Fund Balance Reserve reflect the committed Prop 10 match funds for Welcome Baby. The Unassigned Balance reflects any portion of Fund Balance that is unallocated to a specific purpose and can be allocated at the Commission's discretion without negatively impacting future commitments.
